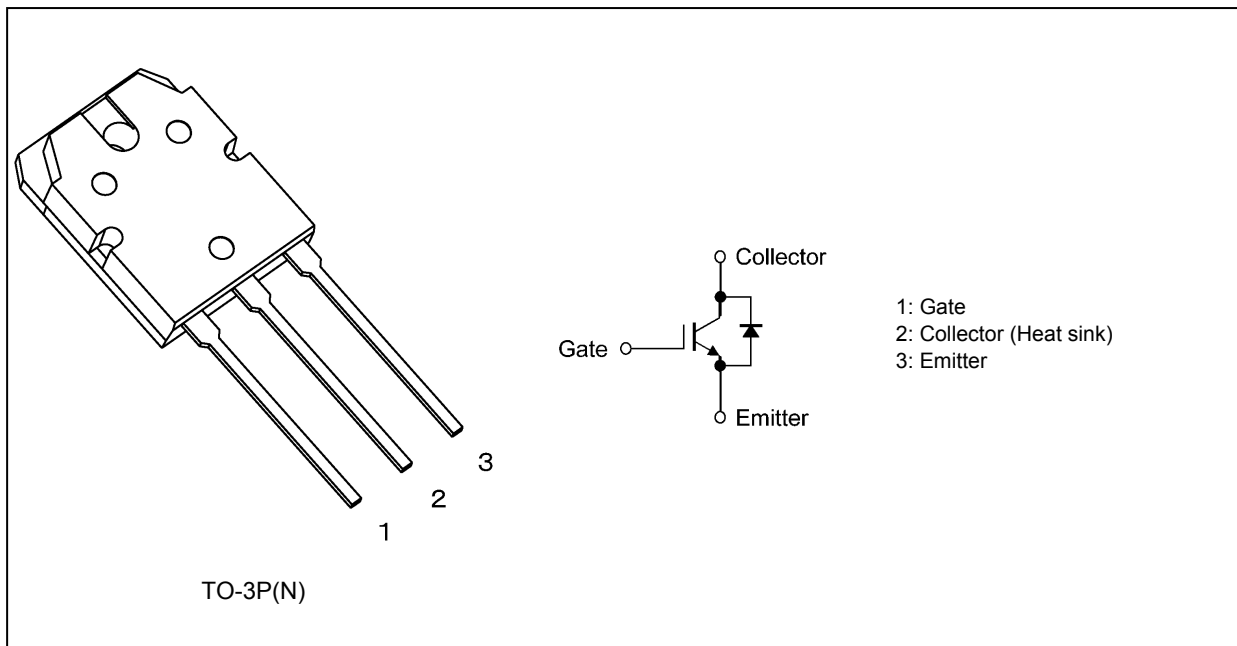

Therefore, please design heat release of a device with due consideration to the temperature rise of IGBT.

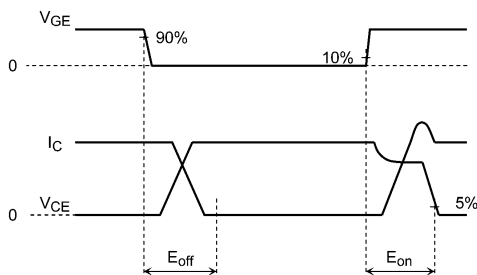

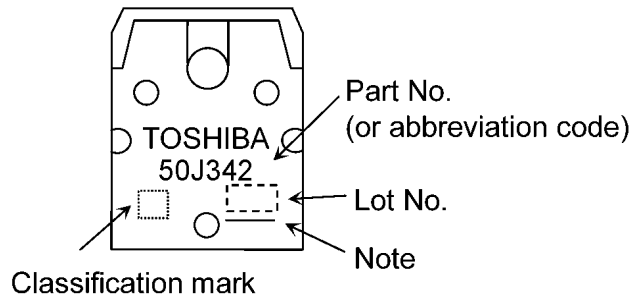
**Fig. 6.2.1 Test Circuit of Switching Time**

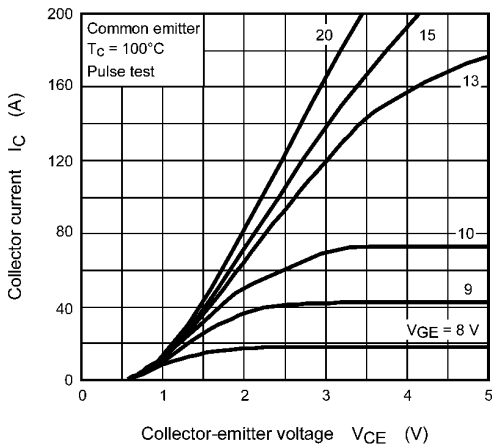

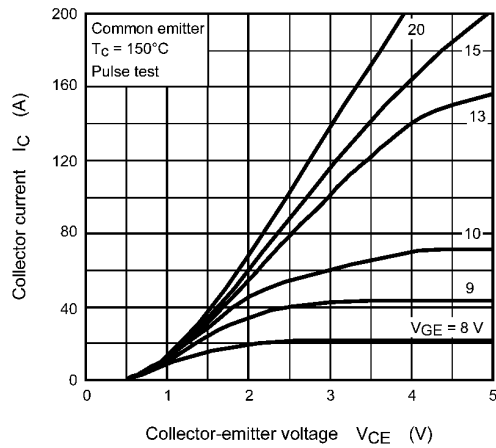
**Fig. 8.1  $I_c - V_{ce}$**



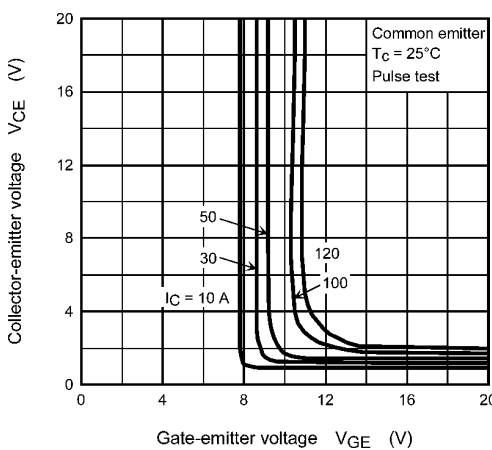
**Fig. 8.2  $I_c - V_{ce}$**



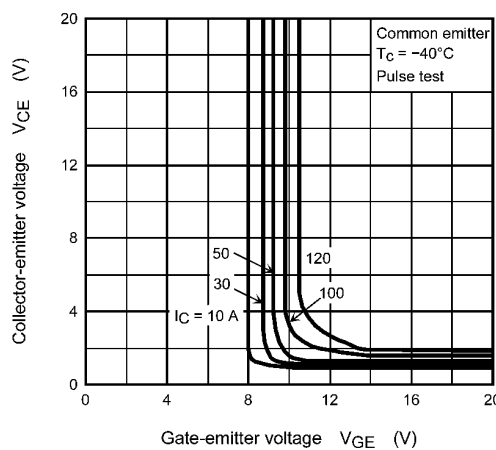
**Fig. 8.3  $I_c - V_{ce}$**

**Fig. 8.6  $V_{ce} - V_{ge}$**

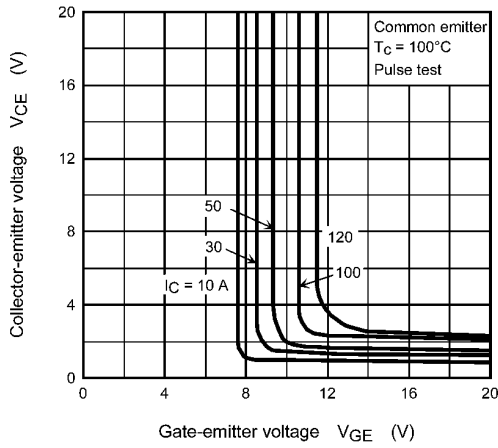


Fig. 8.7  $V_{CE} - V_{GE}$

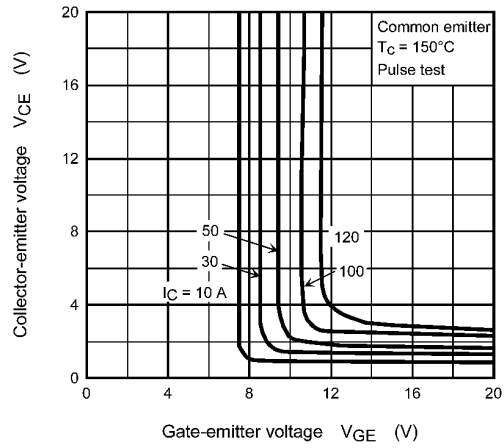


Fig. 8.8  $V_{CE} - V_{GE}$

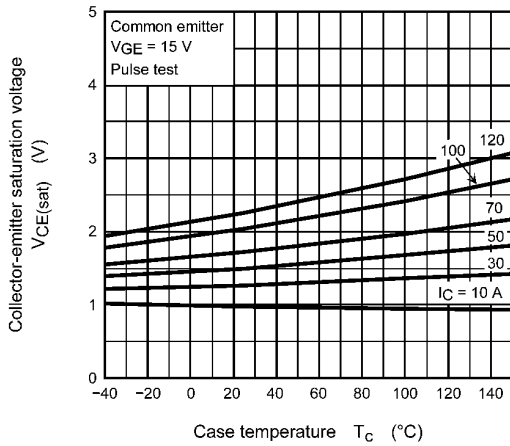


Fig. 8.9  $V_{CE(sat)} - T_c$

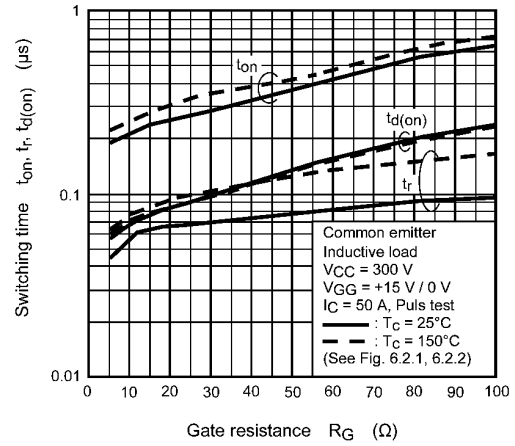


Fig. 8.10  $t_{on}, t_r, t_d(on) - R_G$

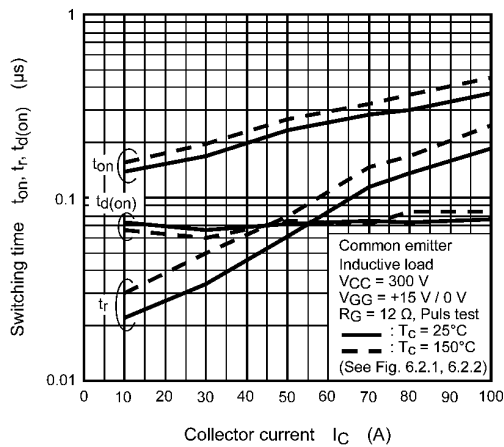


Fig. 8.11  $t_{on}, t_r, t_d(on) - I_C$

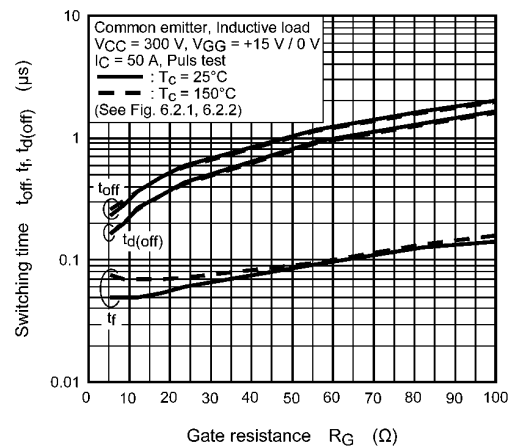


Fig. 8.12  $t_{off}, t_r, t_d(off) - R_G$

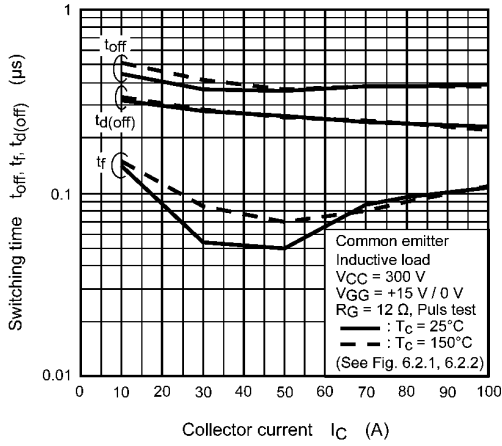


Fig. 8.13  $t_{off}$ ,  $t_r$ ,  $t_d(off)$  -  $I_C$

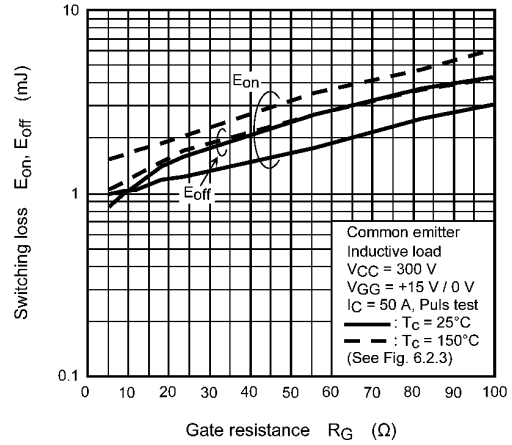


Fig. 8.14  $E_{on}$ ,  $E_{off}$  -  $R_G$

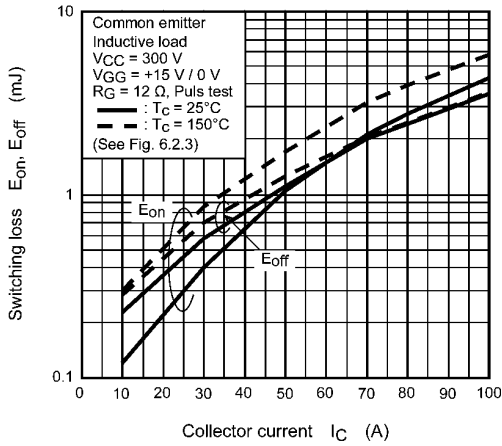


Fig. 8.15  $E_{on}$ ,  $E_{off}$  -  $I_C$

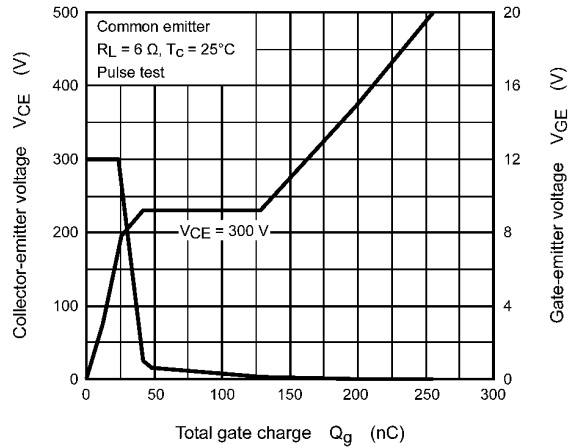


Fig. 8.16  $V_{CE}$ ,  $V_{GE}$  -  $Q_g$

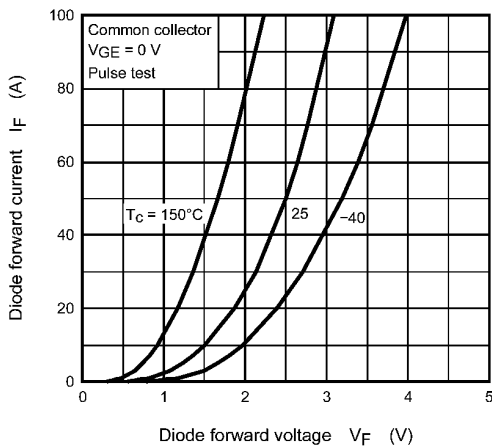


Fig. 8.17  $I_F$  -  $V_F$

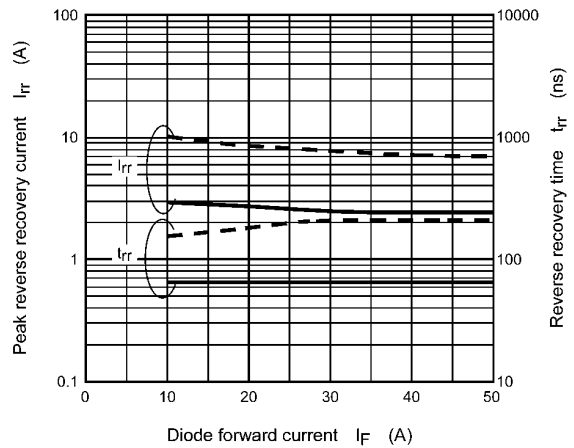
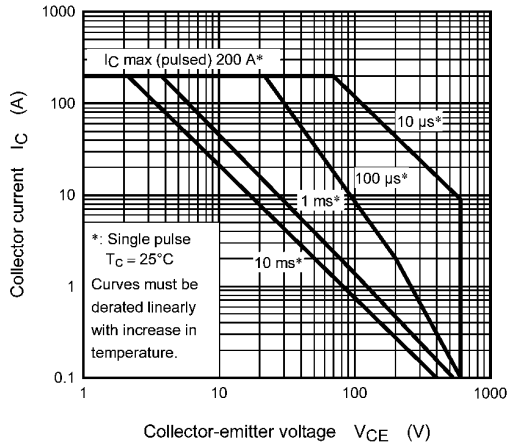
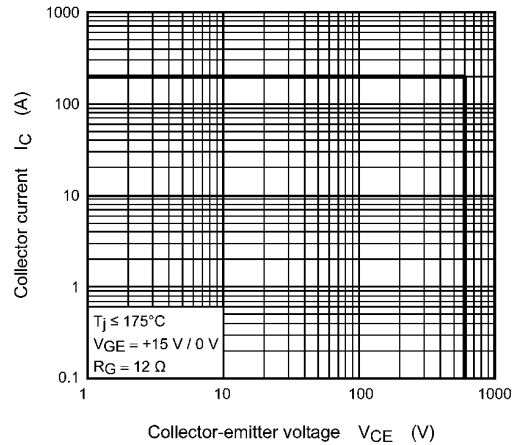


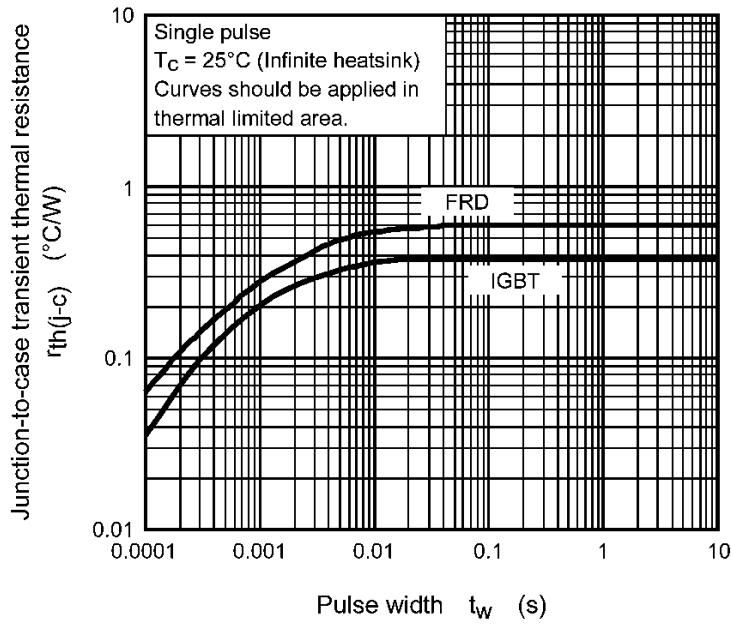
Fig. 8.18  $I_{rr}$ ,  $t_{rr}$  -  $I_F$

**Fig. 8.20 Reverse Bias SOA (Guaranteed Maximum)**



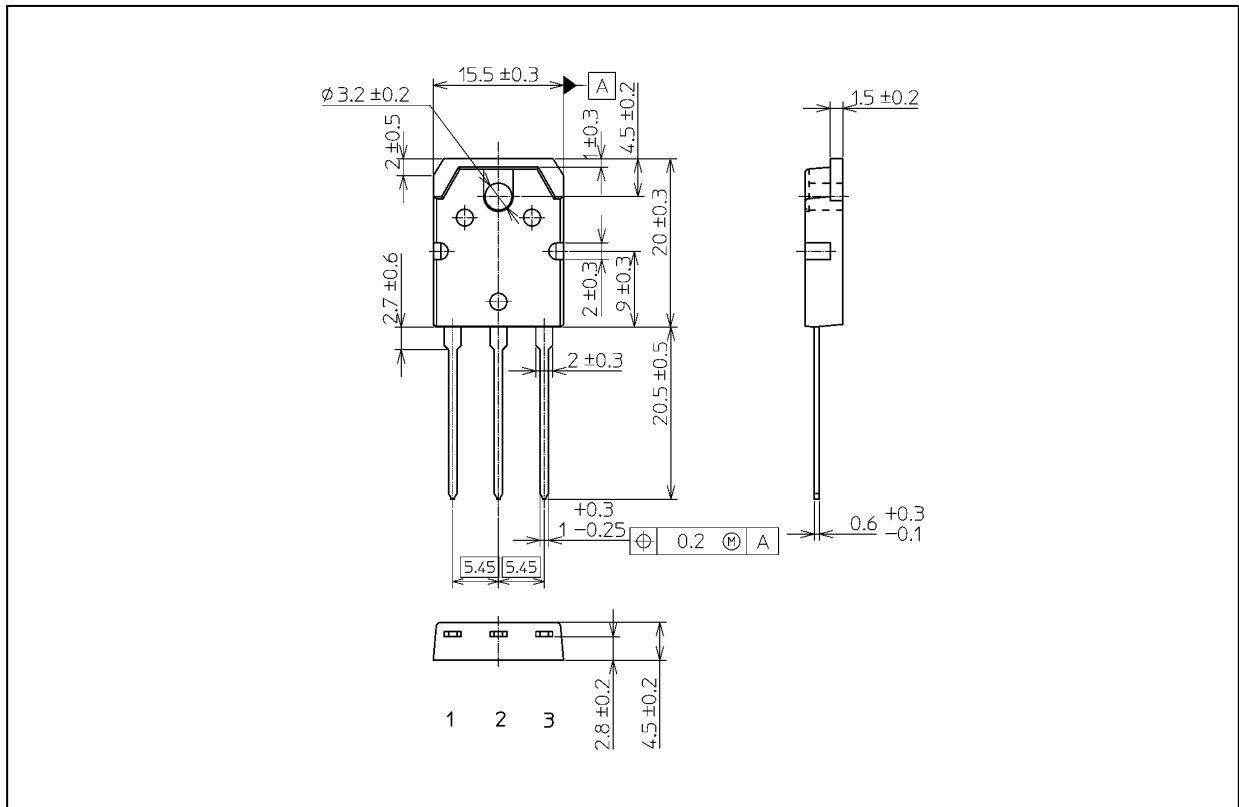
**Fig. 8.21  $r_{th(j-c)} - t_w$  (Guaranteed Maximum)**
